RESOLUTION ADOPTING FY 2013 CLERMONT COUNTY COMMUNITY HOUSING IMPROVEMENT PROGRAM (CHIP) AND AUTHORIZING CHRIS WOJNO LLC TO FILE THE FY 2013 COMMUNITY HOUSING IMPROVEMENT PROGRAM (CHIP) GRANT APPLICATION

WHEREAS, Clermont County desires to participate in the Community Housing Improvement Program by adopting a Clermont County FY 2013 Clermont County Community Housing Improvement Program (CHIP) and by making application to the State of Ohio for said CHIP funds in accordance with the rules and regulations of the Federal government and the Ohio Development Services Agency;

NOW, THEREFORE, BE IT RESOLVED that the Board of County Commissioners of Clermont County, Ohio, does hereby adopt the recommendation of the Clermont County Department of Community and Economic Development and authorizes Chris Wojno LLC to file an application in the amount of \$400,000.00 for the following eligible activities for the FY 2013 Community Housing Improvement Program:
