MICHAEL MINNIEAR, ATTORNEY, AGENT FOR THE PETITIONERS, HAL HOLMES, INC., JOSEPH J. URBAN, JR., LINDA URBAN, PHILLIP E. URBAN, DECEASED, BY ANDREA URBAN, SURVIVING SPOUSE AND PERSONAL REPRESENTATIVE OF PHILIP E. URBAN, ANDREA URBAN, SUSAN E. URBAN, AND JAN M. URBAN,

MARJORIE SUMNER, PROPERTY OWNER, SPOKE IN OPPOSITION EXPRESSED CONCERNS REGARDING WATER/DRAINAGE ISSUES, TRAFFIC CONCERNS, AND DENSITY OF HOUSING.

JIM SUMNER, PROPERTY OWNER, SPOKE IN OPPOSITION, AND EXPRESSED CONCERN THIS WILL CREATE MORE TRAFFIC ISSUES THAN ALREADY EXIST ON HEROLD RD. DUE TO THE TRUCK TRAFFIC FROM S.R. 276 TO ACCESS S.R. 32.

CRAIG RISNER, DEPUTY SURVEYOR, CLERMONT COUNTY ENGINEER'S OFFICE, ADDRESSED THE BOARD OF COUNTY COMMISSIONERS AND PRESENTED AN OVERVIEW OF THE AREA PROPOSED TO BE ANNEXED FROM BATAVIA TOWNSHIP TO THE VILLAGE OF BATAVIA. MR. RISNER STATED THAT THE LEGAL DESCRIPTION PROVIDED ON THE PLAT IS COMPLETE AND ACCURATE FOR ANNEXATION PURPOSES.
