

THE DULY ELECTED MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS OF CLERMONT COUNTY, OHIO, MET IN REGULAR SESSION ON SEPTEMBER 5, 2012, WITH THE FOLLOWING MEMBERS PRESENT: ROBERT L. PROUD, PRESIDENT, EDWIN H. HUMPHREY, VICE PRESIDENT, AND DAVID H. UIBLE, MEMBER. THE MEETING WAS CALLED TO ORDER SHORTLY AFTER 2:00 P.M. BY THE PRESIDENT OF THE BOARD WITH THE PLEDGE OF ALLEGIANCE TO OUR FLAG.

LET THE RECORD SHOW: REPRESENTATIVES FROM BATAVIA TOWNSHIP WERE PRESENT THIS DATE AND PROVIDED A PRESENTATION TO THE BOARD OF COUNTY COMMISSIONERS RELATIVE TO THE PETITION FOR ANNEXATION OF 276.976 ACRES FROM BATAVIA TOWNSHIP TO THE VILLAGE OF BATAVIA, CLERMONT COUNTY, OHIO, PURSUANT TO SECTION 709.023 OF THE OHIO REVISED CODE. ATTENDEES FOR THE PRESENTATION ARE LISTED ON THE ATTACHED ATTENDANCE SHEET. WANDA L. CARTER, ATTORNEY, NEWHOUSE, PROPHATER, LETCHER & MOOTS, LLC., SPOKE IN OPPOSITION OF THE PROPOSED ANNEXATION (REPRESENTING BATAVIA TOWNSHIP). DOCUMENTATION OUTLINING THE ANNEXATION TIMELINE WAS PROVIDED AND REVIEWED. CONDITIONS OF SECTION 709.023(E)(1 THROUGH 7) OF THE OHIO REVISED CODE WHICH WERE NOT MET RELATIVE TO THE PROPOSED ANNEXATION WERE IDENTIFIED INCLUDING OWNERSHIP AND CONTIGUOUS BOUNDARY REQUIREMENTS. A MAP OUTLINING THE PROPOSED ANNEXATION AREA WAS PROVIDED AND REVIEWED.

REPRESENTATIVES FROM THE VILLAGE OF BATAVIA WERE PRESENT THIS DATE AND PROVIDED A PRESENTATION TO THE BOARD OF COUNTY COMMISSIONERS RELATIVE TO THE PETITION FOR ANNEXATION OF 276.976 ACRES FROM BATAVIA TOWNSHIP TO THE VILLAGE OF BATAVIA, CLERMONT COUNTY, OHIO, PURSUANT TO SECTION 709.023 OF THE OHIO REVISED CODE. ATTENDEES FOR THE PRESENTATION ARE LISTED ON THE ATTACHED ATTENDANCE SHEET. JOSEPH L. TRAUTH, ESQ., KEATING MUETHING & KLEKAMP PLL., SPOKE IN FAVOR OF THE PROPOSED ANNEXATION (REPRESENTING THE VILLAGE OF BATAVIA). MR. TRAUTH CHALLENGED THE ACCURACY OF THE UNMET CONDITIONS/ REQUIREMENTS OF SECTION 709.023(E)(1 THROUGH 7) OF THE OHIO REVISED CODE AS SITED BY MS. CARTER AND INDICATED THAT ALL OF THE STATUTORY REQUIREMENTS OF THE OHIO REVISED CODE HAVE BEEN MET FOR THE PROPOSED ANNEXATION.

MS. CARTER FURTHER ADDRESSED THE BOARD FOLLOWING MR. TRAUTH'S PRESENTATION AND REITERATED THAT CONDITIONS/ REQUIREMENTS OF SECTION 709.023(E)(1 THROUGH 7) OF THE OHIO REVISED CODE WERE, IN FACT, NOT MET RELATIVE TO THE PROPOSED ANNEXATION.

MR. TRAUTH FURTHER ADDRESSED THE BOARD STRESSING HIS ARGUMENT THAT THE CONDITIONS/REQUIREMENTS OF THE OHIO REVISED CODE HAVE BEEN MET FOR THE PROPOSED ANNEXATION AS PREVIOUSLY STATED.

COMMISSIONER HUMPHREY INDICATED THAT HE IS IN AGREEMENT WITH BATAVIA TOWNSHIP'S VIEWS WITH REGARD TO THE IMPROPERNESS OF THE PROPOSED ANNEXATION AND THAT THE OHIO REVISED CODE

REQUIRMENTS HAVE NOT BEEN MET. HE FURTHER RECOMMENDED THAT THE ANNEXATION BE DENIED.

COMMISSIONER UIBLE QUESTIONED THE INTENT OF GLEN WIEDENBEIN (PETITIONER FOR SAID ANNEXATION) AND THE VILLAGE OF BATAVIA IN THIS INSTANCE. HOWEVER, HE FURTHER INDICATED THAT, BASED ON THE FACTS STATED TODAY, HE BELIEVES THAT THE VILLAGE HAS MET THE SEVEN REQUIRMENTS OF THE OHIO REVISED CODE REQUIRED FOR THE PROPOSED ANNEXATION.
