

THE DULY ELECTED MEMBERS OF THE BOARD OF COUNTY COMMISSIONERS OF CLERMONT COUNTY, OHIO, MET IN REGULAR SESSION ON NOVEMBER 16, 2016, WITH THE FOLLOWING MEMBERS PRESENT: ROBERT L. PROUD, PRESIDENT, DAVID H. UIBLE, VICE PRESIDENT AND EDWIN H. HUMPHREY, MEMBER. THE MEETING WAS CALLED TO ORDER SHORTLY AFTER 10:00 A.M. BY THE PRESIDENT OF THE BOARD AND THE BOARD OF COUNTY COMMISSIONERS WAS HONORED TO HAVE SOLDIERS OF THE 91ST CIVIL AFFAIRS BATTALION WITH THE UNITED STATES ARMY TO LEAD ALL PRESENT IN THE RECITATION OF THE PLEDGE OF ALLEGIANCE TO OUR FLAG.

LET THE RECORD SHOW THAT THE NOVEMBER 16, 2016 REGULAR SESSION WAS VIDEO RECORDED AND IS AVAILABLE FOR PUBLIC INSPECTION MONDAY THROUGH FRIDAY BETWEEN THE HOURS OF 8:00 A.M. TO 4:30 P.M. LOCAL TIME. IN ADDITION, THE REGULAR SESSION IS AVAILABLE FOR PUBLIC VIEWING THROUGH THE COUNTY GOVERNMENT WEBSITE AT <https://www.youtube.com/user/clermontcounty/playlists>

LET THE RECORD SHOW, members of the 91st Civil Affairs Battalion were introduced. They are working with the County Commissioners to advise in the building of the new live fire range, reviewing the county building evacuation plans and physical fitness and first aid training with the Boy's and Girl's Club of Clermont County.

LET THE RECORD SHOW, Warren Walker, with Duke Energy, provided the Board with an update on the status of the decommissioning plans for the Beckjord Plant in New Richmond. Mr. Walker reviewed the daily operations of the plant currently. He reviewed the development plan and it's compliance with state regulatory laws to ensure a safe resolution. He acknowledged the proposal of the Commissioners requesting to have the ash from the basins removed. Commissioner Proud asked about the expiration of the port permit and addressed the importance of maintaining the port due to the difficulties of obtaining such a permit. Mr. Walker deferred to Mr. Lee Barrett. Mr. Barrett indicated that the permit is still active and they intend to keep it that way. Commissioner Uible suggested that perhaps a public/private cooperative could be established. Mr. Barrett indicated that they are continuing the analysis with the Ohio EPA. Mr. Barrett indicated that they are going to refine the process and plan and are working with the EPA to come to agreement as to what that closure plan would look like. Commissioner Uible asked about the time line for the decommissioning. Mr. Barrett indicated that the plan is being created in compliance with the EPA for engineering and analysis. Commissioner Uible indicated that a letter sent to Cincinnati City Council member, Amy Murray, indicated that fly ash ponds would take 13-15 years to complete. Commissioner Uible asked about the deadline of early to mid-2018. Mr. Barrett indicated that the decommission could take 5-7 years, maybe even 10 years for ash closure. Commissioner Proud indicated that we have had problems with CECOS and PUB well field testing has resulted in well closures in the past. Mr. Barrett indicated that they have continued to do testing quarterly and would respond appropriately. Commissioner Uible indicated the public health and safety of our citizens is his concern. He has been advised that legally they could monitor the site for 30 years and then walk away. Mr. Barrett indicated that the property is jointly owned, there are other stakeholders, and that they alone cannot make decisions. Mr. Uible indicated that there is also the concern that the property could be sold or merged. Mr. Uible also addressed the concern of the Commissioners that 4 months passed with no reply to the letter that was sent. Mr. Barrett indicated that they should have responded sooner. Mr. Uible indicated that they are anxious to work with them and that dialogue is necessary. Mr. Barrett agreed.

LET THE RECORD SHOW: SUKIE SCHEETZ, DIRECTOR, OFFICE OF MANAGEMENT AND BUDGET, ADDRESSED THE BOARD REGARDING THE 2016 OPERATING REVENUES AND THE ANNUAL ESTIMATE OF GENERAL FUND OPERATING REVENUE FOR 2017.

MS. SCHEETZ PROVIDED A PRESENTATION AND REVIEWED ALL REVENUE SOURCES AND THE TREND FOR EACH ITEM; SHE NOTED GENERAL FUND REVENUES ARE INCREASING WHILE TOTAL NON-OPERATING FUNDS CONTINUE TO FLUCTUATE. RELIANCE ON SALES TAX CONTINUES TO INCREASE. MS. SCHEETZ INDICATED THAT THEY ARE RECOMMENDING APPROPRIATING BASED ON THE REVISED 2016 REVENUE ESTIMATES. ADDITIONAL FUNDS SET ASIDE FOR INCREASED SERVICES TO VETERANS AND THE DEPARTMENT OF JOB AND FAMILY SERVICES. MS. SCHEETZ REVIEWED THE ESTIMATED TOTAL IMPACT TO ALL FUNDS. SHE INDICATED THAT THERE IS A BALANCED BUDGET ON OPEATING FUNDS BUT A DRAW DOWN OF APPROXIMATLY 11 MILLION ON CAPITAL FUNDS DUE TO PLANNED COUNTY PROJECTS. THE ESTIMATED TOTAL INCLUDES SALARY ACTIONS AS REQUIRED BY COLLECTIVE BARGAINING AND FOR OTHER SALARY ACTIONS.

COMMISSIONER PROUD REITERATED THAT WE HAVE A BALANCED BUDGET AND THAT WE CONTINUE TO NOT APPROPRIATE MORE THAT WE RECEIVE IN REVENUES.

MS. SCHEETZ FUND BALANCE IS CURRENTLY AT 33% AND THAT IS A SUFFICIENT LEVEL DUE TO THE NATURE OF THE REVENUES THAT THE GENERAL FUND RELIES ON. SHE INDICATED THAT A RESOLUTION TO ADOPT THE 2017 APPROPRIATIONS WOULD BE FORTHCOMING. (16-0519-003)
