RESOLUTION NO. 71-16

DETERMINING TO MAKE IMPROVEMENTS FOR PROJECT NUMBER 6402-62006 KNOWN AS THE COLLECTION SYSTEM REHABILITATION 2016 PROJECT, AS DESCRIBED IN THE ATTACHED EXHIBIT "A" FOR THE COUNTY WASTEWATER SYSTEM, IN THE CLERMONT COUNTY WATER RESOURCES DEPARTMENT, CLERMONT COUNTY, OHIO.

WHEREAS, this Board of County Commissioners of Clermont County, Ohio, has heretofore established the Clermont County Water Resources Department by consolidation of previously existing subsewer districts in the County and provided for a combined County Wastewater System which is presently being operated and maintained therein; and

WHEREAS, this Board of County Commissioners has been advised by the Clermont County Water Resources Department that the improvements described in Exhibit "A" are necessary for the preservation and promotion of the public health and welfare; and

WHEREAS, the Clermont County Water Resources Department has made a detailed examination in order to delineate the work necessary for the improvements described in Exhibit "A" and has prepared plans, specifications and bid documents relative to the improvements along with a cost estimate; and

WHEREAS, improvements described in Exhibit "A" are valid improvements and expenses attributable to the County Wastewater System in the Clermont County Water Resources Department, Clermont County, Ohio.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Clermont County, Ohio:

SECTION 1. By this Resolution which ratifies and declares necessity for the detailed plans, specifications and estimates of cost and financing for the Project as described in the attached Exhibit "A" which exhibit is hereby made a part hereof, in said County, is hereby approved, ratified and confirmed.

SECTION 2. That this Board of County Commissioners hereby declares it necessary for the preservation and promotion of the public health and welfare to construct Project as described in the attached Exhibit "A" which exhibit is hereby made a part hereof.

SECTION 3. That it is hereby determining to proceed with the Project, in accordance with the detailed plans, specifications, and estimates of cost and financing, as herein ratified and confirmed, and to provide for the receipt of bids for the project pursuant to public advertisement therefore in the manner prescribed by law.

SECTION 4. That the work or improvements as described herein shall proceed in accordance with the priority of need and as may be accomplished in conjunction with continued operation of the Clermont County Wastewater System.

SECTION 5. Said construction of certain improvements set forth in Exhibit "A" are more particularly described and set out in the plans, specifications, and estimates of cost and financing, which are on file in the office of the Clermont County Water Resources Department, 4400 Haskell Lane, Batavia, Ohio 45103, where they may be examined.

SECTION 6. That the entire cost of the Project, including engineering fees, legal fees, and all necessary and incidental expenses in connection therewith shall be paid from one or more of any combination of the Wastewater Replacement and Improvements Fund, Wastewater Capital Improvement Fund, any portion of any federal or state grant or loan should such become available, and/or by the issuance of notes or bonds pursuant to Section 133.08 of the Ohio Revised Code, and payable from revenues derived from sewer rates and charges levied for the operation of the Clermont County Wastewater System.

SECTION 7. That this Board of County Commissioners hereby finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION 8. That a copy of this resolution be certified to (a) the County Auditor of Clermont County, Ohio within fifteen (15) days after passage hereof, as provided in Section 319.61 of the Ohio Revised Code, and (b) the County Sanitary Engineer for information.

**COLLECTION SYSTEM REHABILITATION 2016 PROJECT
PROJECT NO. 6402-62006**

This project consists of the rehabilitation of approximately 3,243 LF of gravity sewer using cured-in-place pipe on 8-inch main; approximately 17,969 LF of gravity sewer using cured-in-place pipe on 18-inch diameter sewers; reinstatement and rehabilitation of approximately 97 6-inch sewer laterals using cured-in-place lining; installation of approximately 97 new cleanouts; rehabilitation of approximately 84 4-foot diameter manholes, including application of approximately 865 VF of polymeric coating. This work will take place in various locations throughout Clermont County, including Old State Route 32 and Clermont Mercy Health Hospital in Batavia Township, Amelia-Olive Branch Road in Batavia Township, and Seabrook Way in Union Township.

RESOLUTION DECLARING THE NECESSITY TO CONSTRUCT, MAINTAIN, AND OPERATE THE WATERWORKS SYSTEM IMPROVEMENTS FOR PROJECT NUMBER 6401-60132 IDENTIFIED AS THE PLUM STREET WATER PETITION PROJECT (HEREINAFTER CALLED THE "PROJECT") LOCATED WITHIN GOSHEN TOWNSHIP, AS MORE FULLY DESCRIBED IN THE ATTACHED EXHIBITS "A" AND "B", WITHIN THE COUNTY WATERWORKS SYSTEM IN THE CLERMONT COUNTY WATER RESOURCES DEPARTMENT, CLERMONT COUNTY, OHIO, AND FIXING THE LOCATION, ROUTE AND TERMINI OF THE WATER EXTENSION AND SETTING THE DATE, TIME AND PLACE WHEN OBJECTIONS TO OR ENDORSEMENTS OF SAID IMPROVEMENTS WILL BE HEARD.

WHEREAS, the Board of County Commissioners has heretofore established the County Waterworks System in the Clermont County Water Resources Department, in Clermont County, Ohio, by consolidating previously existing districts; and

WHEREAS, based upon receipt of a petition for water service dated 01/27/15 from property owners along Plum Street in Goshen Township, said Board of County Commissioners has heretofore adopted Resolution Number 102-15 on 06/24/15 approving the revised General Plans of the County Waterworks System in the Clermont County Water Resources Department, Clermont County, Ohio, to include said Project for the preservation and promotion of the public health and welfare and to provide an adequate water supply for consumption and fire protection and has accepted, approved and ratified detailed plans, specifications, estimates of cost and financing, and tentative assessment roll for the construction, maintenance, and operation of the Project and authorized notice sent to owners of property affected by said Project whose property is classified on the County Auditor's list as being in a conservation program, agriculturally used, or in Current Agricultural Use Valuation (CAUV) taxation and may or may not be located within a designated Agricultural District, by Resolution Number 61-16 adopted on 05/11/16.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Clermont County, Ohio, (the "Board");

SECTION 1. That this Board of County Commissioners hereby declares it necessary for the preservation and promotion of the public health and welfare and to provide an adequate water supply, quality and quantity for consumption and fire protection, as petitioned by the property owners along Plum Street in Goshen Township to construct, maintain and operate the Project as part of the County Waterworks System in the Clermont County Water Resources Department, Clermont County, Ohio.

SECTION 2. That the location, route and termini of the Project in said County Waterworks System of the Clermont County Water Resources Department is fully described in Exhibit "A", attached hereto and made a part hereof.

SECTION 3. That the assessment and improvement area shall consist of properties bounding and abutting on the water main extension or right-of-way wherein the water main extension is constructed as described in Exhibit "A".

SECTION 4. That the improvements shall consist of the construction, maintenance, and operation of the water main extension as part of the County Waterworks System, and as more particularly described and set out in the detailed plans, specifications, estimates of cost and financing, and tentative assessments which are on file in the Office of the Board of County Commissioners of Clermont County, Ohio, at 101 East Main Street, Batavia, Ohio 45103, and the Office of the Clermont County Water Resources Department at 4400 Haskell Lane, Batavia, Ohio 45103, where they may be examined.

SECTION 5. That the estimated cost of operation and maintenance of the water main extension is \$165.00 per year.

SECTION 6. That the entire cost of constructing said Project, including construction costs, engineering fees, legal and administrative fees, and all necessary and incidental expenses in connection therewith, is currently estimated at \$83,950.00, and shall be paid from the following sources:

- A. The levy and collection of special assessments against benefited property abutting on the water main extension or the right-of-way in which it is constructed currently estimated at \$75,960.00, as set out in Exhibit "B", attached hereto and made a part hereof, and/or the proceeds of general obligation bonds and/or certificates of indebtedness (notes) in anticipation thereof, pursuant to and in compliance with Chapters 6103 and 133 of the Ohio Revised Code, and payable from the special assessments certified for collection to the real estate tax bill, computed as follows:
1. Basic Benefit Assessment of an amount per benefited parcel calculated based upon 100% of the assessable project costs at \$9,660.00, as identified in Exhibit "B", with the total assessable project cost currently estimated at \$67,620.00 of which \$28,980.00 will be paid for by the Clermont County Water Resources Department's County Waterworks System Capital Improvement Fund representing the basic benefit assessment amount for three (3) properties to be benefitted but already connected to water via private easements; and
 2. A supplemental unit Improvement Benefit Assessment based on $\frac{3}{4}$ " meter and installation costs at \$810.00 per connected improved or unimproved property, representing three (3) properties, for a total amount of \$2,430.00 and a water system capacity charge at \$1,970.00 per single family residential unit connected to the County Waterworks System, representing three (3) improved property parcels, for a total amount of \$5,910.00. The total estimated Improvement Benefit Assessment for said Project is \$8,340.00. The Improvement Benefit Assessment is at the option of the property owners desiring to have these costs incorporated herein. A charge at least equal to said supplemental Improvement Benefit Assessment costs shall be paid, in addition to other fees and expenses, at the time unimproved abutting property is improved and makes connection to the County Waterworks System or at the time a property is connected that has not immediately connected and has not desired these costs to be incorporated herein.
- B. A contribution of the Clermont County Water Resources Department's County Waterworks System Capital Improvement Fund in the estimated amount of \$7,990.00 representing engineering performance and 100% of legal, administrative, and miscellaneous fees associated therewith.

SECTION 7. That endorsements of and/or objections to the construction of the Project as described herein, the character and termini thereof, the boundaries of the assessment district, the tentative assessments, and the apportionment of the cost and assessments, will be heard by the Board of County Commissioners on the 13th day of July, 2016, at 10:30 A.M. Local Time in the Session Room of the Office of the Board of County Commissioners, 101 East Main Street, Batavia, Ohio 45103 and written objections to or endorsements of the

proposed Project will be received by this Board of County Commissioners for a period of five (5) days after the date of said hearing.

SECTION 8. That notice of this Resolution shall be (a) published once a week for two consecutive weeks in a newspaper of general circulation in the County, on Thursday, June 16, 2016, and Thursday, June 23, 2016, and such other newspaper publications as the County Commissioners may determine, and (b) notice by certified mail of the passage of this Resolution mailed to the Clerk of each municipality within the water service area and to each property owner to be assessed for the cost of said Project, or otherwise affected by the Project, between the dates of the first and second publication in the newspapers, as prescribed by law.

SECTION 9. That the property owners to be assessed have the right to pay their assessment(s) in the principal amount(s) during the first thirty (30) days, or longer period, following passage of the resolution levying final assessments, or property owners may pay their assessment(s) over the assessment certification period, which period shall not exceed twenty (20) years, at the calculated uniform interest rate necessary to pay assessment bond interest as sold.

SECTION 10. That there is at least one property within the assessment district that is classified in a conservation program, agriculturally used, or are in Current Agricultural Use Valuation (CAUV) and may or may not be located within a designated Agricultural District according to the Clermont County Auditor's tax list. Special water assessments may be levied on properties lying within designated Agricultural Districts but may not be collected, except for assessment bond interest, or without the owner's permission until the use changes. This Project will remain open for property owners to apply for Agricultural District designation until the point of levying final assessments.

SECTION 11. This Board of County Commissioners hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**RESOLUTION APPOINTING MEMBERS TO THE CLERMONT COUNTY
TRANSPORTATION IMPROVEMENT DISTRICT (CCTID) BOARD OF TRUSTEES**

WHEREAS, the Board of County Commissioners of Clermont County, Ohio, adopted Resolution No. 124-06 on June 21, 2006 which created the Clermont County Transportation Improvement District (CCTID), pursuant to Chapter 5540 of the Ohio Revised Code, to empower the various political subdivisions and their respective residents within the County, to participate in a cooperative county-wide coalition to take advantage of the opportunities and benefits made available only through a TID to plan, construct and improve highways, roads, bridges, interchanges and accompanying capital improvements and development throughout Clermont County and its surrounding counties, such as Hamilton County and specifically regarding the Eastern Corridor Multi-Modal Project, and

WHEREAS, the Board of County Commissioners of Clermont County, Ohio, (the "County") has been provided with certain informational materials regarding the proposed Cincy Eastern I-75/71 Bypass (the "Bypass"); and

WHEREAS, *Economic Development and Access Issues* are critically important to not only the County but the overall Region as well; and

WHEREAS, after having reviewed the informational items regarding the Bypass, the Board of County Commissioners believes that the County specifically, and the Cincinnati-Northern Kentucky Region generally, would significantly benefit from the construction of the Bypass, as the Bypass would contribute substantially in terms of regional transportation and economic benefits to the development and economic growth of the entire region.
