MR. HICKS STATED HIS OPINION THAT THERE HAS BEEN A DRAMATIC IMPROVEMENT IN THE QUALITY OF THE BOARD OF COUNTY COMMISSIONER' MEETING MINUTES AND COMPLIMENTED THE BOARD OF COUNTY COMMISSIONERS FOR THIS CHANGE. HE STATED HE DOES NOT KNOW IF THE CHANGE IS A RESULT OF THE LONGER APPROVAL PROCESS OR NOT; HOWEVER, IN HIS OPINION, THE MINUTES NOW REFLECT A MUCH MORE COMPLETE ACCOUNT OF WHAT IS HAPPENING IN THE MEETING
- **JOINT APPLICATION FOR EMPLOYMENT OF OUTSIDE LEGAL COUNSEL**
MR. HICKS EXPRESSED HIS APPRECIATION FOR THE BOARD OF COUNTY COMMISSIONERS NOT MOVING TOO FAST ON THIS ISSUE. SUBSEQUENT TO HIS ACKNOWLEDGMENT OF HIS RECENT TOUR OF THE COUNTY JAIL, HE FURTHER COMMENTED ON THE RATE OF PAY OF PUBLIC DEFENDERS AND STATED THAT HE BELIEVES IT IS IMPORTANT TO CAREFULLY CONSIDER THE TAXPAYERS MONEY BEING SPENT ON LEGAL DEFENSES.
- **FCC COOPERATIVE AGREEMENT**
MR. HICKS STATED THAT THE FCC COOPERATIVE AGREEMENT CHANGE WAS APPROVED BY THE CITY OF MILFORD, OHIO, ON DECEMBER 4, 2018, HE FURTHER STATED THAT HE HOPES THIS ISSUE GETS PROPER CONSIDERATION BEFORE ANY DECISIONS ARE MADE.
- **GEORGE H. W. BUSH CEREMONY**
MR. HICKS EXPRESSED HIS APPRECIATION TO THE BOARD OF COUNTY COMMISSIONERS FOR THE CEREMONY HELD IN SESSION THIS DATE HONORING FORMER PRESIDENT GEORGE H. W. BUSH AND COMPLIMENTED THE CLERMONT COUNTY SHERIFF'S HONOR GUARD. MR. HICKS FURTHER EXPRESSED HIS ADMIRATION AND RESPECT FOR BOTH FORMER PRESIDENT GEORGE H. W. BUSH, AS WELL AS, FORMER PRESIDENT RONALD REAGAN.
