**DISCUSSION:** Pat Manger, County Engineer, addressed the Board of County Commissioners with regard to the proposed establishment of the Harvest Ridge Stormwater District. Mr. Manger stated that the trend for the creation of Stormwater Districts is increasing and he expects to see more in the future. Mr. Manger compared the process for creating a Stormwater District for a new subdivision versus a fully developed subdivision like Harvest Ridge Subdivision. He

stated that his preference is to plan the establishment of a Stormwater District at the beginning stage of a subdivision development in order to prepare and plan for maintenance and replacement of the infrastructure over time. Mr. Manger explained that the utility fee for the Harvest Ridge Subdivision will decrease considerably when the debt service is paid. He stated that there has been a lot of work and discussions/meetings held regarding the proposed Harvest Ridge Stormwater District and that this is the last step in the process for its establishment. Mr. Manger further stated that the Harvest Ridge Stormwater District is a good example for future Stormwater Districts, given the fact that a lot of obstacles were overcome for its establishment. It was noted that, from a monetary standpoint, the County is held harmless and that all of the fees and costs for work needed is recovered in the fees collected from the property owners in the Stormwater District.

Commissioner Painter stated that Stormwater Districts can provide relief to individual property owners within subdivisions that are required to solely maintain stormwater drainage on their property that serves the subdivision, with no contribution by other property owners. This approach allows everyone in the subdivision to work together and equitably share costs accordingly. Mr. Manger stated that the Home Owners Associations (HOAs) created or established for County subdivisions may or may not know about drainage issues and that the County, though the establishment of a Stormwater District, is best suited to deal with stormwater issues. The County has the knowledge and experience to make appropriate repairs and/or replacements as needed for the Stormwater Districts.
