This software program would improve the accuracies and efficiencies of the Auditor's Office current assessment process and the evaluation of that process. This would allow the data to be retrieved much quicker. Mr. Mehlman stated that data collection that would normally take hours or days to collect could be collected in minutes. In, addition, this would allow for increased transparency, allowing property owners to clearly see how their values were derived.

Commissioner Corcoran asked Mr. Mehlman to review the basics of what this software can do.

Mr. Mehlman provided Ms. Corcoran with an example of how the software would be used for a residential assessment.
